## GYM VENTURES INC. PARTY RELEASE FORM

The Terms shall serve as release and assumption of risk of my heir, heirs, executor and administrator and all family and guests.

A \$125 deposit is required at the time of booking. The balance is due on the date of the party. If the party is cancelled between the day of the booking and 30 days prior to the party, this deposit will be refundable as gym credit. Cancellations less than 30 days will result in a loss of the deposit.

I am aware that individual and group publicity photos and videos are taken from time to time and in consideration for my or my child(rens) participation I hereby grant my permission for my child's likeness to be used in *Gym Ventures, Inc.* publicity and advertising.
